## REGISTRATION & WEATHER REFUND INSURANCE POLICY

*The Registration & Weather Refund Insurance must be purchased during your registration for the US OPEN*



### How much is the insurance?

*Pros (if playing in at least one Pro Event): \$30 All Other Entrants: \$20*

### Who is covered:

*The Registration Refund Insurance covers only the individual player who purchased the insurance during registration for the US OPEN. It does NOT cover your partner unless they have purchased the insurance also.*

### What does it cover?

*100% refund of your Registration and Event fee if you need to cancel out of the tournament before you check in to register for your first event, for the following reasons:*

- > Injury - doctors note required
- > Illness/Disease - doctors note required
- > Jury Duty - Copy of jury duty notice required
- > Your partner pulls out of the tournament, and you do not participate in the event

**Please note: If you apply for a full refund, you are not eligible to receive US OPEN Player gifts.**

*100% refund of your Event fee ONLY (excluding registration fee) is refunded for the following reasons:*

- > If your event gets completely cancelled due to weather. If your event starts on the assigned day and gets cancelled (with no make-up options) due to weather, you are eligible for an event refund.
- > If you get sick or injured before your event starts, and your partner DOES NOT find a replacement.

### Insurance **does NOT** cover the following: (no refund)

- > If your event starts and the format of the event gets altered, due to weather, you will not be eligible for a refund.
- > If you get disqualified for any reason out of the tournament
- > If you do not show up for your assigned court on time
- > If your partner forfeits for any reason during the event
- > If you sign up for the wrong skill level and you get disqualified
- > If you start your event but need to forfeit due to injury or medical reasons
- > Pro events that are re-scheduled due to rain and you decide not to participate
